BENEFACTORS of the WEST VIRGINIA LAW REVIEW

The West Virginia Law Review Endowment (1993)

The West Virginia University College of Law has established a fund known as the West Virginia Law Review Endowment. The endowment is managed by the West Virginia University Foundation with the income dedicated to enhancements for the *West Virginia Law Review* not provided for in the College of Law's general budget. These enhancements include special equipment needs, student participation in national conferences and seminars, special recognitions and awards, and secretarial assistance for special projects above and beyond ordinary operations. Enhancements do not include the cost of printing, mailing, marketing, general secretarial compensation, and office supplies; these are general operational budget expenses and are funded through subscription revenues and the College's general budget.

The West Virginia Law Review Endowment provides former members of the *West Virginia Law Review*, law alumni, members of the Bar, and other friends a means by which they can make private donations to help the *Law Review* fund much needed enhancements and improvements. The initial gift to this endowment was made by Stephen G. Young, a 1964 graduate of the College of Law and Associate Editor of Volume 66 of the *West Virginia Law Review*. This generous gift was made in memory of Ann Keel for whom this issue is dedicated. Consolidation Coal Company, of which Mr. Young is the Vice President for Government Affairs, has kindly matched his gift. Other individuals have made smaller gifts in memory of Ann Keel and those funds have also been placed in the West Virginia Law Review Endowment.

This is the second endowment created during the 1992-93 academic year in support of the *West Virginia Law Review*. Earlier this year, the Ralph J. Bean Law Review endowment was established through gifts from the Bean family and friends (see Volume 95, Number 2 of the *West Virginia Law Review*).
