OIL PORTRAITS OF PROFESSOR ST. GEORGE TUCKER BROOKE AND PROFESSOR WILLIAM P. WILLEY.—At the suggestion of many former students of the College of Law and with the cordial approval of the President of the University and of the law faculty, a competent portrait painter has been employed to paint oil portraits of Professor Brooke and Professor Willey, who were the first professors of law in the University, the service of the former dating from the founding of the College of Law in 1878 and of the latter from 1884. The long experience of Mrs. E. Uhler Grumbine, who will paint these portraits, and the uniformly high excellence of her work, assure results which should be highly satisfactory to the numerous members of the West Virginia bar who hold these first professors in the College of Law in the highest respect. The portraits will be life-size and three-quarters length, and will be placed at the landing on the monumental staircase leading from the class-room floor to the library floor in the new law building.

Reliance is placed upon the lawyers of West Virginia, and particularly upon the former students of the College of Law, to supply funds to pay for these portraits and also to place in the new

law building a suitable bronze memorial tablet which many think should be placed there in memory of the West Virginia lawyers who served in the World War. It is proposed that any funds remaining after the portraits and memorial have been paid for shall be devoted to the purchase of engravings and etchings of distinguished judges and lawyers to be hung in the new building. The inspiration to the students and the legal atmosphere given to the building by such portraits and memorials should add much to the dignity and usefulness of the new structure.

ATTENDANCE AT COLLEGE OF LAW IN 1919-20.—The catalog of the College of Law which has been recently issued shows that the attendance during the past year numbered 66, of whom 29 were first-year students, 16 were second-year students, 17 were third-year students, and 4 were special students. The number of first-year students and the total number registered for the degree of Bachelor of Laws are slightly larger than in any previous year.
