THE COLLEGE OF LAW.—The College of Law is pleased to announce that James W. Simonton will return to the faculty next September. Professor Simonton resigned in 1921 to join the law faculty at the University of Missouri, where he has been since that time, with the exception of the year 1924-5, which he spent at the Harvard Law School, from which he received the degree of S. J. D. He has also, in the meantime taught in the Summer Sessions of Cornell and Leland Stanford, Jr., Universities. Professor Simonton, therefore, returns to us richer in learning and experience which, together with the sound and thorough knowledge of West Virginia law he acquired during his former professorship here, will make him a peculiarly valuable addition to the faculty.
