And this rule as to briefs and oral arguments shall apply to all motions to dismiss, affirm, modify or reverse, made pursuant to section twenty-six of said chapter one hundred and thirty-five of the Code, as amended by said chapter sixty-nine of the Acts of the Legislature of 1915. (Italics indicate the amendments made December 4th, 1917.)

RECENT SUPREME COURT RULINGS ON QUESTIONS OF APPELLATE PRACTICE.—A recent decision of the Supreme Court of Appeals, in *City of Wheeling v. The Chesapeake & Potomac Telephone Company*, a certified case from Ohio County, holds that by § 5, Rule 1, Rules of Practice of the Supreme Court of Appeals, a case under § 1, c. 135, of the Code, cannot be certified to the Supreme Court from an order or proceedings had in vacation,—in this case, an order awarding a temporary injunction, upon bill, without
